Notice of Proposed Rules

Date in parentheses indicates when rules were filed with the Legislative Research Council. Copies of proposed rules may be obtained for no charge at https://rules.sd.gov or from the agency directly.

<u>Department of Human Services</u>: (January 9, 2025) intends to amend a rule to remove the requirement of human rights committee review of medication prescribed for treatment or stabilization of psychiatric conditions or sedation prior to medical or dental procedures and make such reviews optional at the request of the participant or their guardian, and add the requirement that during each annual individualized service plan (ISP) meeting, the conflict-free case manager will ask if a review is requested. The rule requiring human rights committee and ISP approval before sedation will be repealed as the process is covered in the amended rule. The general authority for this rule, as cited by the department, is SDCL <u>27B-2-26</u>.

A public hearing at which persons may present amendments, data, opinions, and arguments for or against the proposed rule will be held at the Hillsview Building, Seasons Conference Room, 3800 East Highway 34, Pierre, South Dakota, on March 7, 2025, at 10:00 a.m. (CT). Interested persons may also participate by Microsoft Teams at https://sd-dhs.org/March-7th-Rules-Hearing. Copies of the proposed rule may be obtained without charge from, and written comments on the proposed rule may be sent to, the Department of Human Services, 3800 East Highway 34, c/o 500 East Capitol Avenue, Pierre, South Dakota 57501 or by email to DHSInfo@state.sd.us. Copies of the rule is also available at https://rules.sd.gov. The deadline to submit any written comments for consideration by the department is March 21, 2025. This hearing is being held in a physically accessible location. Persons with special needs for which the department can make arrangements may call (605) 773-5990 at least 48 hours before the public hearing.

Petition for Rules

The **Department of Game, Fish and Parks** on January 7, 2025, served on the Interim Rules Review Committee and the director of the Legislative Research Council, a petition received from an interested person, per <u>SDCL 1-26-13</u>, to establish an administrative rule to eliminate the use of rifles during the East River deer hunting season and allow only muzzleloaders and shotguns to be used. The <u>Game, Fish and Parks Commission</u> was scheduled to review the petition at its January 9, 2025, meeting.
