Department of Game, Fish and Parks: (October 16, 2025) intends to amend rules to establish a resident allocation of sixty percent of first draw licenses for trophy bison bull licenses and non-trophy bison bull licenses. The general authority for these rules, as cited by the department, is SDCL [41-2-18](#) and [41-17-1.1](#).

A public hearing at which persons may present amendments, data, opinions, and arguments for or against the proposed rules will be held at the Outdoor Campus-West, 4130 Adventure Trail, Rapid City, South Dakota, on November 6, 2025, at 2:00 p.m. (MT). 10-23-2025	South Dakota Transportation Commission (Department of Transportation) : Amend rules to, in Edmunds County, extend the current forty-five mile per hour speed limit on U.S. Highway 12 westward from Ipswich past the intersection with 357 th Avenue, clarify the starting points for speed zones, and revise speed zone measurements to the nearest one-tenth of a mile; and in Moody County, change the speed limit on State Trunk Highway 34 in and around the Interstate 29 interchange and revise speed zone measurements to the nearest one-tenth of a mile; 52 SDR 39, October 6, 2025.
