The **South Dakota State Board of Dentistry** on October 23, 2025, served on the Interim Rules Review Committee and the code counsel, a report on the final action taken on a petition received from an interested party, per [SDCL 1-26-13](#). At its October 10, 2025, meeting, the [Board of Dentistry](#) denied a petition which sought to amend an administrative rule to allow unregistered dental assistants to administer nitrous oxide and monitor patients under nitrous oxide.
