South Dakota Lottery Commission (Department of Revenue): (May 15, 2026) intends to adopt rules for the updated Millionaire for Life game and the new Powerball Xs and Os game, and repeal obsolete rules. The general authority for these rules, as cited by the commission, is SDCL [42-7A-21](#).

SCHEDULED PUBLIC HEARINGS

5-18-2026	<u>Department of Labor and Regulation:</u> Adopt rules to establish the State Apprenticeship Agency (SAA). Specifically, the rules define administrative duties, registration procedures, program standards, review requirements, actions involving apprenticeship programs, reciprocity processes; and complaint procedures; and align South Dakota with federal apprenticeship requirements under 29 CFR Part 29, allowing the SAA to administer, register, oversee, and enforce Registered Apprenticeship Programs requirements at the state level; 52 SDR 100, April 21, 2026.
5-19-2026	<u>South Dakota Division of Insurance (Department of Labor and Regulation):</u> Amend rules to update the sources referenced in rule and incorporate the 2026 Medicare Supplement coverage amounts set by the federal government; 52 SDR 103, May 4, 2026.
5-28-2026	<u>South Dakota Cosmetology Commission (Department of Labor and Regulation):</u> Amend a rule to allow the Cosmetology Commission to apply relevant work experience toward education hours for out-of-state applicants who have cosmetology-related licenses that are not equivalent to licenses issued by the commission; 52 SDR 106, May 11, 2026.
6-2-2026	<u>South Dakota Board of Nursing (Department of Health):</u> Adopt and amend rules to remove the requirement for the board to notify a nursing education program of an applicant's licensure examination results; remove the requirement for the board to issue renewal certificates and inactive status cards; and allow registered nurses to delegate gastrostomy tube care to a nursing assistant; 52 SDR 97, April 20, 2026.
