6-18-2026	<u>South Dakota Board of Pharmacy (Department of Health):</u> Amend and adopt rules to provide a new rule set for remote drop sites and add an operational waiver process to rules for pharmacies, and repeal obsolete rules in Article 20:51; 52 SDR 116, May 26, 2026.
6-22-2026	<u>South Dakota Board of Education Standards (Department of Education):</u> Amend and repeal rules to eliminate unnecessary barriers to certification; clarify the requirements to obtain certification; ensure educators are adequately trained; provide additional flexibility for certain renewals; and clarify and update language; 52 SDR 119, June 1, 2026.
6-23-2026	<u>South Dakota Commission on Gaming (Department of Revenue):</u> Amend and adopt rules to modify existing provisions to the most recent version of the ARCA standard for medications; offer a variation of play and corresponding pay table for a new poker game called Three Card Prime; offer variations of play and corresponding pay tables for existing blackjack games 21 + 3 and Double Down Madness; and offer a variation of play and corresponding pay table for a new blackjack game called TriLux Blackjack Progressive; 52 SDR 116, May 26, 2026.

7-14-2026	<u>South Dakota Animal Industry Board (Department of Agriculture and Natural Resources):</u> Amend rules to update definitions to more accurately reflect current terminology; modernize the language of reference material; and add municipal or other permitted solid waste landfills as facilities at which certain animal carcasses may be disposed of, to reflect current practice; 52 SDR 119, June 1, 2026.
