Dear Director Holwegner,

In accordance with South Dakota Codified Law § 49-31-53, the Department of Human Services is required to report annually to the South Dakota State Legislature on the status of the access fee charged to landline phones and cell phones in the State. I am hereby submitting the recommendation that the current \$.15 access fee is sufficient to continue the Telecommunications Relay Services Program and Captioned Telephone Relay Services, and I recommend that the fee stay the same. This recommendation is based on the following information:

- 1. Number of lines and units that have been established and are assessed the access fee (Attachment 1),
- 2. Number of minutes being utilized by the relay service in South Dakota (Attachment 2), and
- 3. Revenues based on the State's Accounting System for deposit into the Telecommunication Fund for the Deaf (Attachment 3).

The fund balance at the close of SFY21 was \$2,699,140.19.




SD Department of Human Services Telecommunication Relay Services Cumulative Number of Lines/Units per Annual Period, by Category Type (Attachment 1)
