Brand Board Legislative Report for Calendar Year 2022

The South Dakota State Brand Board is a law enforcement agency which operates on funds generated from the brand registration program and the brand inspection program. The Brand Board does not receive any general fund appropriations. **The registration and the use of brands apply to the entire state.** The livestock ownership inspection area in South Dakota is west of the Missouri River. Any livestock leaving this inspection area must have a livestock ownership inspection or transportation permit prior to leaving. Livestock sold at livestock markets in western SD are inspected for ownership at the markets. Livestock sold privately must also have ownership inspections. Members of the Brand Board are appointed by the Governor and confirmed by the Senate. Brand Board members are Scott Vance, Faith; Myron Williams, Wall; Lyle Spring, Union Center; David Paul, Mud Butte and Haven Stuck, Rapid City. The Brand Board employees full time brand inspectors, stationed at 10 livestock markets in western SD, part-time/local brand inspectors, office staff, and brand enforcement/livestock investigators.

Livestock Inspections

In CY (calendar year) 2022 a total of 1,675,636 head of livestock were inspected. This is a decrease of 142,316 head from 2021. Due to drought conditions in 2021, a record number of livestock were inspected and sold which resulted in fewer livestock carried over in 2022 and presented for sale. Ninety holds were submitted to the Brand Board office pending proof of ownership. Table 1 shows the inspections by month for each category. Table 2, which lists CY 2021 information, is included for comparison purposes. Some of the reported numbers are subject to change as data may be received in the brand office after the completion of this report.

Deposits for Inspection

Monthly inspection receipts, from fees collected at livestock markets and local inspections, are shown in Table 4. Fees collected for locker plants and feedlot inspections are included in the livestock market totals. Since July 1, 2013, the brand inspection fee is a \$1.00 per head plus mileage. The current mileage rate, of \$.51/mile, is set by the Board of Finance. The inspection receipts listed below do not include the mileage fees collected for local inspections. The brand inspectors are reimbursed for mileage. The CY 2021 fees are included for comparison purposes.

Missing or Stolen Livestock

The number of livestock reported missing or stolen in CY 22 **decreased** by 324 head as compared to CY 21. The head count and type of livestock reported missing or stolen in CY 22 are listed in Table 5. The numbers reported for CY 21 are listed in Table 6. Some of the livestock reported missing or stolen may be the result of a civil dispute between producers, lenders taking possession of their security, or livestock may have died. Livestock which has been found or recovered may have been found by the owner, brand inspectors, livestock investigators or other law enforcement officials. **Producers who believe their livestock has been stolen should contact their local law enforcement immediately.** The Brand Board works

with other law enforcement agencies on missing/stolen livestock cases. Although the Brand Board's investigators do not have jurisdiction on tribal ground, they assist as requested.

As a service to livestock producers, the *Aberdeen News Farm Forum Green Sheet*, *Cattle Business Weekly*, *Tri-State Livestock News*, and *Tri-State Neighbor* publish the Monthly Missing Livestock Report at no cost to the Brand Board.

Recovered Strays

While conducting local brand inspections or inspecting livestock at livestock markets, strays are recovered by brand inspectors. Table 7 below shows the number and type of livestock recovered during inspections completed for years 2018 thru 2022.

Brand Board Holds

A hold is placed on livestock sale proceeds if proof of ownership has not been established by the seller of the livestock or the livestock was an estray. Prior to sending the proceeds to the Brand Board office, sellers are given 60 days, after the sale date, to prove ownership. Brand inspectors assist sellers to resolve the hold. If proof of ownership has not been provided after 60 days, then the funds are submitted to the Brand Board and held as “Restricted Funds”. Although the seller is responsible to provide proof of ownership, staff in the Brand Office conduct additional research in an attempt to resolve the hold. Holds, which have been submitted to the Brand Board office, are shown below in Table 8. The head count of livestock held at livestock markets, feedlots, locker plants and local inspections are included in Tables 1 and 2 on pages 2 and 3. If a hold was for an estray, brand board staff review grazing reports, missing livestock reports, obtains information from Animal Industry and from brand offices, in surrounding states, to try to determine the owner. Detailed listings of Holds Received, Paid, Pending, and Escheated to the Theft and Prevention Fund are included in the Appendix of this report.

**Theft and Prevention Fund

Livestock Investigations:

If someone believes their livestock has been stolen, they should contact their local law enforcement immediately. The Brand Board assists local law enforcement statewide in the investigation of missing or stolen livestock. Many circumstances are civil cases. Criminal cases are submitted to States Attorneys by the Brand Board investigators. The States Attorneys make the determination if charges are filed. Expenses for the brand enforcement/investigator are paid from the Brand Fund. The main source of revenue for the Brand Fund is brand renewals. One full time brand enforcement/investigator was employed for the first half of 2022 and an interim investigator was employed during the second part of 2022. The interim investigator was previously employed as the Chief Livestock Investigator for the State of Arizona and has done an outstanding job.

Brand Program

The Brand Board is also responsible for brand registrations, transfers, brand renewals, shipper permits, grazing permits, and trailing permits. 11Table 10 shows the main brand program revenue for 2022 and 2021. Brands are renewed every five years. The next renewal period will be January 1 - May 1, 2025. If a brand owner does not renew their brand by May 1st of the renewal year, the brand owner has two years to re-record their brand. Summary

In calendar year 2022, the number of livestock reported missing or stolen **decreased** by 324 head. Stray livestock recovered by brand inspectors was 110 head. This livestock was either returned to the owner or sold and the proceeds paid to the owner. The number of livestock inspected in CY 22 decreased by 142,316 head due to large selloffs the previous year caused by drought conditions. In CY 2022, there were \$122,441.00 worth of livestock sold without proof of ownership. The funds were placed on hold, pending proof of ownership. Without brand inspections, this amount would have been paid to the sellers regardless, no proof of ownership required.

If anyone believes their livestock has been stolen, they should **contact local law enforcement immediately**. The Brand Board's website sdbrandboard.sd.gov has a link to the SD Sheriff's Association which lists the Sheriffs' contact information. The Brand Board assists local law enforcement statewide on cases of missing or stolen livestock.

Total livestock reported missing or stolen for CY 22 was 283 head. This is down from the 607 head reported in CY 21. In addition to receiving reports of missing livestock, the Brand Board receives hundreds of calls each year. Some topics are trespass livestock, livestock ownership disputes, questions on brand and ownership inspection laws.

The Brand Board has seen an increase in the number of civil disputes regarding livestock ownership. Producers are urged to file the necessary documents to protect their operation when placing their livestock in the care of others or when caring for another producer's livestock.

The Brand Board issues shipper permits, grazing permits, and trailing permits at no cost to the producers. Shipper permits allow producers to take their livestock out of the inspection area to an open market, without being inspected, as they will be inspected at the livestock market. Horses going to markets in Nebraska from the SD brand inspection area, must have a local inspection prior to leaving. A grazing permit is issued to those producers who have imported cattle for grazing which are branded with an out of state brand. If a pasture is divided by the state line, trailing permits may be issued to allow livestock to walk back and forth without a brand inspection.

The foundation of the brand inspection program is requiring sellers to provide proof of ownership. Without brand inspections, anyone could sell livestock without having to provide proof of ownership.

Currently, there are approximately 27,000 registered brands in South Dakota. The fee to renew a brand registration is \$18.00/year. This fee is paid every five years which totals \$90.00/brand. A portion of this fee support the brand enforcement/livestock investigator. No ownership inspection fees are used for livestock investigator expenses.
