### Overview

In 2013, the South Dakota Legislature passed SB 235, which established the Building South Dakota (BSD) Fund. According to the bill, each year 30% of the BSD fund is to be transferred to the Workforce Education Fund (WEF). Initially, WEF dollars were to be used for three purposes: to cover the State's share of the Limited English Proficiency (LEP) adjustment in the State Aid to General Education Funding formula for fiscal years 2014 through 2016; to provide secondary career and technical education grants; and to provide additional one-time funding to school districts.

Over the years, those purposes have been modified by the Legislature. The State's share of the LEP adjustment is now covered with general funds through the General State Aid to Education formula. The one-time funding to school districts was changed to provide for one-time education enhancement programs. And, in 2018, the Legislature passed SB 81, which limited the fund to providing grants for new and existing secondary career and technical education programs.

This report provides information regarding the secondary career and technical education (CTE) grants.

# Secondary Career and Technical Education Grants (Workforce Education Grants) Overview:

First awarded in FY2016, the Workforce Education Grants provide school districts and private, nonprofit entities in South Dakota the opportunity to make transformative change in CTE programs. High quality CTE programs give students the knowledge, skills, and experiences to be well prepared for postsecondary education and the workforce. Partnerships among secondary education, postsecondary education, and business and industry lay the foundation for modern CTE programs. These grants efficiently increase the number of students with access to high quality CTE programs in the state. Currently the Legislature appropriates \$490,000 annually to fund these grants, with authority of up to \$1.25 million.

## Who is Eligible:

Eligible applicants are Local Education Agencies (LEAs) and private, nonprofit entities with projects designed to serve middle and high school students. Entities that are awarded grants will serve as fiscal agents through the completion of their projects. All applications must demonstrate commitment by all grant partners to the grant project and its sustainability following the conclusion of the grant.

Proposed projects must meet the following criteria:

- 1. Build, reform or enhance an approved secondary CTE program;
- 2. Align to high-skill, high-demand, and high-wage careers and postsecondary education programs in South Dakota; and
- 3. Demonstrate the ability to complete the project.

Proposed projects must fall within one or more of the following categories:

- 1. Evaluation for alignment to postsecondary education and workforce demands;
- 2. Development of career pathways or programs of study;
- 3. Development of career guidance or work-based learning programs;
- 4. Educator training;
- 5. Facilities;
- 6. Equipment; or
- 7. Instructional materials.

The Workforce Education Grants are awarded through a competitive submission and review process. As such, grant teams are expected to make significant and meaningful improvements to CTE programs; applications should not be one-off projects for small equipment purchases, student transportation, or similar activities. Projects should be completed within 18 months, and a one-to-one match is required.

Priority is given to projects that demonstrate one or more of the following characteristics and meet the requirements outlined in SD Administrative Rule 24:10:47:

- A project evaluating local CTE systems for the purposes of redesigning approved secondary CTE programs;
- An innovative project demonstrating alignment to postsecondary education and South Dakota workforce needs and including work-based learning, dual or concurrent credit courses and any applicable CTSO;
- A project which includes collaboration between multiple secondary schools;
- A project demonstrating partnerships with postsecondary education and business or industry;
- A project including industry-grade practices, equipment, and student certifications;
- A project integrating academic content, work-readiness skills, and entrepreneurship education;
- A project increasing access to and support for approved secondary CTE programs in rural areas;
- A project including plans for sustainability;
- A project which supports the retention of highly effective teachers, career counselors, and administrators for approved secondary CTE programs.

#### **Grants Awarded:**

Grants totaling \$7,864,960.31 have been awarded from FY2016 through the end of FY2024. A complete history of school districts and other entities awarded Workforce Education Grants can be found at the end of this report.

A snapshot of recent projects and the impact they make include:

#### **Edgemont School District**

The Edgemont School District utilized their grant to purchase heavy equipment simulators. These simulators will allow students to train on 11 various pieces of heavy equipment: excavator, backhoe, wheel loader, articulated dump truck, bulldozer, motor grader, forward simulator, harvester simulator, skid steer, forklift, and telehandler. This project also provides students the opportunity to obtain an industry-recognized certification, specifically NCCER (National Center for Construction Education and Research) certification, which in turn shows potential employers these students have a level of proficiency before they are even hired. Ultimately, the use of these simulators will provide students with more options to easily transition to a post-secondary college or the workforce.

#### Parker School District

To provide a safer environment for student learning, the Parker School District is building and expanding their Agriculture, Food & Natural Resources facility. This newly created space will provide advanced offerings to help expose students to career and technical education courses in a safe environment that encourages students to gain the necessary skills to enter the workforce or post-secondary and succeed. This project will also expand workforce connections in and around their community. These students will be able to partner with surrounding businesses and learn how their work in the classroom will help prepare them for the workforce. The project will assist the district in their long-term goals of adding additional career and technical education programs in the upcoming years.

#### **Sioux Falls School District**

The Sioux Falls School District (SFSD) applied their grant funds to create a mock veterinary clinic. This will allow students to develop technical knowledge and practical skills for proper animal handling, animal behavior and biosecurity principals to combat the spread of infectious agents within the production facility or animal hospital. The overall goal of the SFSD is to develop one of the best agricultural and animal science training programs for high school students in the nation. The SFSD also partnered with local veterinary clinics, pet shops, and post-secondary education institutes to ensure this project will provide their students with the knowledge, skills, and experience needed to move forward in their futures with confidence.

#### Wall School District

To meet the local workforce demands, the Wall School District committed to add a Career and Technical Education (CTE) wing to their current school building with the use of their award. The CTE addition will provide students a safe environment to participate in industry certification as well as modern career and technical education. The extension will consist of a welding/fabrication shop, a woodworking/construction shop with finishing room, and additional CTE classrooms. With an updated space, more students will have the opportunity to learn technical skills and knowledge safely. In turn, the CTE programs will prepare students for post-secondary education as well as the workforce. The Wall School District is hopeful their students will want to remain in the area after their secondary education because of how prepared they are to help build the workforce especially with the expansion of an industrial park and over forty housing developments in the Wall community.

Grants are awarded in the spring of each grant year. As of August 19, 2024, there are five Workforce Education Grants open with a balance of \$962,275.00 remaining on the grants. Details of the open grants are in the table on the next page:
