My name is Dennis Phillips. I am speaking in support of SJR 502.


My wife and I moved to Rapid City from Colorado in 2022. We saw that South Dakota was honoring the original Constitution, unlike Colorado. We believed our move was Divinely confirmed when we learned that South Dakota's motto was "under God the people rule".

Unfortunately, the Federal Government is failing in its responsibilities to ensure our freedoms. Since the Founding of our nation, the Federal system has expanded to 15 Executive Departments and 100s of agencies and commissions with a great deal of redundancy in their various missions. Instead of the short 7-page original Constitution, the Federal Government operates under a 3000-page document containing court-adjudicated interpretations by the Supreme Court. In addition, unelected bureaucrats in the plethora of departments and agencies have written almost 100,000 pages into the Code of Federal Regulations that control almost every aspect of our lives. Our Supreme Court, our Executive Branch, and our Congress have failed to protect the people from unconstitutional overreach. We deeply fear that our four grandchildren will not get their opportunity to pursue the American Dream as we have.

Article V gives the state legislatures the power to rein in the runaway Federal Government. South Dakota should join the 19 other states that have already passed a Convention of States resolution. There is broad popular support for it.
