

Why update now?

- The State's core financial system and "System of record," was implemented in 1988.
- BFM has discussed the need to modernize for many years.
- Fragmented financial systems.
- The critical system is at risk of failure from:
 - Lack of vendor support
 - Obsolete technology
 - Staffing challenges





What is an ERP?

An Enterprise Resource Planning (ERP) system facilitates the flow of information across multiple financial units. It allows for the seamless integration of systems and creates a comprehensive view of the enterprise to support decision making.

Modernize State financial management systems by implementing a cloud-based Enterprise Resource Planning (ERP) solution.


Goal 2

Project BISON Costs

- Total Appropriation of \$70.0M
 - System Implementation Services \$26.8M
 - Software Subscriptions \$15.8M

- On Schedule, On Budget




ERP Software & System Implementation RFP Development

- Requirements Gathering Effort
 - 102 staff participated, representing 22 agencies
 - 33 workgroup meetings
 - 1,000+ system requirements identified
 - 30+ essays developed
- Vendor Demonstration Scripts
 - 55 staff, representing 12 agencies, participated in drafting 298 script scenarios that 3 RFP finalists demonstrated during in-person software demos

Transformational Effort Focused on Standardization and Industry Best Practices


- Elimination of agency shadow systems (decreasing dual-entry or duplicative work)

Be Bold - The State is pursuing transformational change, not incremental improvements, in our financial business processes and systems. We will fundamentally change the way State financial business is conducted by using the Oracle Cloud solution set.

Inclusivity - Project decisions will benefit the entire State of South Dakota. All aspects of the State will be accounted for, and appropriate State subject matter experts consulted, when making difficult decisions.

Simple - Seek the simplest solution that aligns with best business practices inherent in the Oracle Cloud solution. Strive to eliminate manual, non-value-added tasks in business processes.

Operational Standard - Business processes and the associated Oracle Cloud application configuration will operate uniformly throughout the State. Creating unique business processes for different agencies is highly discouraged.

No Shadow Systems - The perpetuation of shadow systems, either through standalone applications or interfaces to third-party applications, will be minimized or eliminated. If functionality of a third-party or shadow system is achievable within the Oracle Cloud solution set, that system should be eliminated.
