-Kevin, Sarah, Caleb & Micah Impecoven. Both sides of our families are 5th generation (with the 6th generation just about ready to take over!) land owners. It is disheartening that any business can claim eminent domain and render that land dangerous for normal

farming practices going forward. Let's start by simply talking about the pipelines' safety and the impact construction would have on farmland and underlying drainage systems. CO2 is heavier than air. If there is a leak, it just hovers close to the ground. Who breathes that? The people and livestock living there. How does it affect those living in the area? DEATH- The cloud kills all those caught in its plume! What about insurance? What company is going to ensure farmers who farm around the pipeline when it's so dangerous? Missouri had a similar issue and the insurance company left those farmers out to dry. Who is going to deal with the weeds that grow on the pipeline land? Additionally, this pipe is 24 inches thick and runs at 250,000 lbs of pressure. It's compressed like dry ice. Then when it is released, like in the situation of a leak, it expands and could do so explosively. The pipe is only 4 feet underground - it could easily be ruptured accidentally. Have you seen the video of the Norwegian risk-management company, DNV, intentionally rupturing a small carbon dioxide (CO2) pipeline to learn about the dispersion of the poisonous gas. The deadly gas may extend beyond the visible cold-cloud plume because, as it warms, it becomes invisible. Our farmland has been in the family over a 100 years, so this situation has us concerned that if any corporation can claim eminent domain and take land from other farmers when does our land get confiscated. PLEASE STOP THE LAND GRAB!

For-profit, out-of-state Companies/Corporations are attempting eminent domain "confiscation" of landowner rights and private property, attempting to justify climate change for these actions.
