

WE ALSO HEREBY GRANT EASEMENTS TO RUN WITH THE LAND FOR DRIVEWAYS, WATER, DRAINAGE, SEWER, GAS, ELECTRIC, TELEPHONE OR OTHER PUBLIC UTILITY LINES OR SERVICES UNDER, ON OR OVER THOSE STRIPS OF LAND DESIGNATED HEREON AS EASEMENTS.

WE FURTHER GRANT AND CERTIFY THAT THE ROADWAY SHOWN AS WINDSONG PLACE IS A PRIVATE ROADWAY EASEMENT WHICH IS HEREBY RESERVED AS A PERMANENT UNOBSTRUCTED ACCESS. SAID EASEMENT IS FOR VEHICULAR AND PEDESTRIAN TRAVEL OVER SAID ROADWAY FOR THE PURPOSE OF ACCESS TO THE ABUTTING PROPERTY. IT IS UNDERSTOOD THAT THE OWNER, THEIR LESSEES AND ASSIGNEES HAVE THE RESPONSIBILITY WITH RESPECT TO MAINTAINING SAID PRIVATE ROAD. SAID GRANT IS TO RUN WITH THE LAND.
