Remote or Written Testimony



Session Committees

The Committee Chair may permit a person to appear from a remote site and give testimony through the use of Microsoft Teams. A person may submit a digital handout or written testimony. People wishing to

just listen to the live meeting may click the 🏓 or visit <u>SD.net</u>.

Remote Testimony

A person may submit a request to appear from a remote site and give testimony before a committee (JR 7-28). Submit the request at least 24 hours before the scheduled meeting to the committee email address provided on the committee detail webpage. Include the following information:

- a. Name: Your first and last name
- b. City of Residence: Your city of residence
- c. **Representing:** For those testifying as a registered lobbyist, please indicate you are a registered lobbyist and include the organization you represent. For all other persons wishing to testify, please state that you are representing "self".
- d. Bill Number: Bill number you wish to address
- e. Proponent or Opponent: Whether you are a proponent (for) or opponent (against) the bill
- f. Meeting Date: Date of the meeting during which your bill will be heard

Digital handouts may be attached to the email as a PDF or Microsoft Word document.

Testimony from a remote site is permitted at the discretion of the committee chair.

Testifiers who are approved by the committee chair will receive a Microsoft Teams invitation to the committee meeting. During the meeting, the committee chair will call on you by name at the appropriate time to offer your comments. (See <u>Microsoft Teams for Committee Testifiers</u>) The committee chair may prioritize in-person testimony.

Written Testimony

Any written testimony or digital handout received, at least 24 hours before the scheduled meeting, is shared with the committee members and made available online at <u>sdlegislature.gov</u>.

Submit written testimony or a digital handout to the committee email address provided on the committee detail webpage. Include the following information:

- a. Name: Your first and last name
- b. City of Residence: Your city of residence
- c. **Representing:** For those testifying as a registered lobbyist, please indicate you are a registered lobbyist and include the organization you represent. For all other persons wishing to testify, please state that you are representing "self".
- d. Bill Number: Bill number you wish to address
- e. **Proponent or Opponent:** Whether you are a proponent (for) or opponent (against) the bill
- f. Meeting Date: Date of the meeting during which your bill will be heard
