Senate Bill 1**AMENDMENT 1C FOR THE INTRODUCED BILL**

This bill has been extensively amended (hoghoused) and may no longer be consistent with the original intention of the sponsor.

1 An Act to provide for the decennial redistricting of the Legislature.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That chapter 2-2 be amended with a NEW SECTION:

21 **Section 5. That § 2-2-44 be AMENDED:**

22 **2-2-44.** The state shall be divided into thirty-five representative districts, which
 23 shall be the same as the senatorial districts provided in ~~§ 2-2-43~~ section 1 of this Act, and
 24 the House of Representatives shall consist of seventy members.

25 **Section 6. That § 2-2-45 be AMENDED:**

26 **2-2-45.** Each senatorial district as provided for in ~~§ 2-2-43~~ section 1 of this Act is
 27 entitled to one senator.

28 **Section 7. That § 2-2-46 be AMENDED:**

1 **2-2-46.** Each representative district as provided for in § 2-2-44 is entitled to two
2 representatives. However, in order to protect minority voting rights, District No. 26 and
3 District No. 28 shall each consist of two single-member house districts as provided in ~~§§ 2-~~
4 ~~2-47 and 2-2-48~~ sections 2 and 3 of this Act.

5 **Section 8. That § 2-2-49 be AMENDED:**

6 **2-2-49.** The Legislature finds that, for the purposes of §§ 2-2-41 to 2-2-51,
7 inclusive, the ideal population of a senatorial district, based on the official ~~2010~~ 2020
8 federal census, is ~~23,262~~ 25,333 people. For a house district, the ideal population, based
9 on the official 2020 federal census, is 12,667 people.

10 **Section 9. That § 2-2-50 be AMENDED:**

11 **2-2-50.** For the purposes of §§ 2-2-41 to 2-2-51, inclusive, voting district (VTD)
12 boundaries are those boundaries in existence on April 1, ~~2010~~ 2020, and utilized by the
13 ~~2010~~ 2020 federal census.

14 **Section 10. That § 2-2-51 be AMENDED:**

15 **2-2-51.** If any area of this state is omitted from the provisions of ~~§ 2-2-43~~, section
16 1 of this Act the county auditor of the county containing the area shall attach the area to
17 the district that surrounds it or, if the area is contiguous to two or more districts, the
18 county auditor shall attach it to the contiguous district that has the least population
19 according to the official ~~2010~~ 2020 federal census. Any attachment made pursuant to this
20 section shall be certified in writing and filed with the secretary of state. No changes may
21 be made in any such attachment until the next decennial redistricting.
