**House Concurrent Resolution  
6012**

**AMENDMENT HCR6012C FOR THE INTRODUCED BILL**

1 **A CONCURRENT RESOLUTION, urging the development of options for ensuring**  
2 **continued visitation of patients and residents in nursing facilities and assisted**  
3 **living centers.**

4 WHEREAS, each day, the talented and dedicated people who staff South Dakota nursing  
5 facilities and assisted living centers work tirelessly to ensure that the patients and residents  
6 entrusted to them receive the best possible care; and

7 WHEREAS, during the COVID-19 pandemic, the day-to-day challenges of operating  
8 nursing facilities and assisted living centers became exponentially increased by the need to  
9 prepare for and address the high rates of infection, morbidity, and mortality being seen in like  
10 settings across the country; and

11 WHEREAS, the vulnerable nature of their patients and residents, combined with the  
12 inherent risks of congregate living in a healthcare setting, caused the imposition of aggressive  
13 measures to limit exposure to COVID-19 and the spread of COVID-19 within each facility and  
14 center; and

15 WHEREAS, these aggressive measures included restricting virtually all in-person visitation  
16 and interaction with friends, family, and non-essential healthcare personnel; and

17 WHEREAS, the resulting physical separation took an immeasurable emotional and physical  
18 toll on patients and residents, as well as on their loved ones; and

19 WHEREAS, for many patients and residents, the social isolation led to increases in  
20 depression, anxiety, and distress; and

21 WHEREAS, for patients and residents with cognitive impairments or other disabilities, the  
22 restrictions were also confusing and upsetting; and

1        WHEREAS, the institutional efforts to mitigate the risk of infection among patients and  
2 residents resulted in an unintentional but seriously detrimental violation of the right to receive  
3 visitors at the time of the patient's or resident's own choosing;

4        NOW, THEREFORE, BE IT RESOLVED, by the House of Representatives of the Ninety-  
5 Seventh Legislature of the State of South Dakota, the Senate concurring therein, that while  
6 safeguarding the health and wellbeing of this state's vulnerable elderly population is a  
7 laudable goal and not easily achievable during a pandemic, the measures undertaken in  
8 pursuit of that goal ~~must never again result in the de facto imprisonment and~~ should strive to  
9 minimize sequestration of our elderly family members, friends, and neighbors; and

10       BE IT FURTHER RESOLVED, that nursing facilities and assisted living centers be urged to  
11 work collectively for the development and implementation of options that safeguard the health  
12 and well-being of their patients and residents, while recognizing that quality of life is greatly  
13 dependent on regular and frequent personal interactions that promote physical, mental, and  
14 psychosocial well-being; and

15       BE IT FURTHER RESOLVED, that the members of the South Dakota congressional  
16 delegation be urged to join with their counterparts from the other states to ensure that any  
17 federal statutes, regulations, guidance, and orders addressing the health and well-being of  
18 patients and residents, in nursing facilities and assisted living centers, during a pandemic,  
19 incorporate ongoing visitation and personal interactions, and support the efforts of the  
20 facilities and centers to provide such opportunities to patients, residents, and their loves ones.
