Senate Bill 14**AMENDMENT 14A FOR THE INTRODUCED BILL**

1 **An Act to revise the legal description for the construction of a National Guard**
2 **Readiness Center in Sioux Falls, make an additional appropriation therefor,**
3 **and to declare an emergency.**

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 **Section 1.** There is hereby appropriated from the general fund the sum of \$667,000 and the
6 sum of \$2,001,000 in federal fund expenditure authority to the Department of the Military,
7 for purposes of designing and constructing a National Guard Readiness Center in Sioux Falls.
8 This amount is in addition to the amount appropriated for the same project by 2022 Session
9 Laws, Chapter 196 § 1.

10 **Section 2.** The adjutant general of the Department of the Military shall approve vouchers and
11 the state auditor shall draw warrants to pay expenditures authorized by this Act.

12 **Section 3.** Any amounts appropriated in this act not lawfully expended or obligated shall
13 revert in accordance with the procedures prescribed in chapter 4-8.

14 **Section 4. That chapter 196, § 1 of the 2022 Session Laws be AMENDED:**

15 **Section 1.** There is hereby appropriated from the general fund the sum of
16 \$5,685,920 and the sum of \$16,291,974 in federal fund expenditure authority to the
17 Department of the Military, for purposes of design and construction of a National Guard
18 Readiness Center in Sioux Falls, and to authorize and support activities related to the
19 following property exchange:

20 (1) An approximately 32.96-acre parcel located on East Benson Road and North
21 Sycamore Avenue in Sioux Falls that is currently owned by the state, with the
22 following description: ~~Tract 3 less the western most five (5) acres of said Tract,~~
23 ~~and all of Tract 4, Tract 4 and Tract 5 of~~ Knabach Addition to the City of Sioux Falls,

1 ~~Located in the SE1/4 of Section 35, T102N R49W of the 5th P.M., City of Sioux~~
2 ~~Falls, Minnehaha County, South Dakota; and~~

- 3 (2) An approximately 38.88-acre parcel located on the future North Bahnson Avenue
4 Road in Sioux Falls that is currently owned by the Sioux Falls Development
5 Foundation, with the following description: Tract 3 (excepting Lot H1), East Benson
6 Addition to the City of Sioux Falls; a portion of an unplatted parcel of land described
7 as the Northwest 1/4 (Except H1 through H5, Lacey's Tract 2, Lacey's Addition,
8 Lacey's 2nd Addition and Runge's Addition); and a portion of an unplatted parcel
9 of land described as the West 1/2 of the Southwest 1/4 (excepting Lot H1, Lot H2
10 and Sioux Empire Development Park 8 Addition), all located in Section 35,
11 Township 102 North, Range 49 West of the 5th P.M. City of Sioux Falls, Minnehaha
12 County, South Dakota North Bahnson Avenue in Sioux Falls with the following
13 description: Lots 1 and 2 in Block 3 of Sioux Empire Development Park 8 Addition
14 to the City of Sioux Falls, Minnehaha County, South Dakota.

15 **Section 5.** Whereas, this Act is necessary for the support of the state government and its
16 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
17 full force and effect from and after its passage and approval.
